 - Working on a process during a work session in the next few weeks.
 - 6205 Turkey Hollow has requested a small area in front of his house to be artificial turf. Shared a sample with the BOD.
- **3.** CC & Rs Committee (Jim Burns (chair), Mark Fisette, Joann Richards, Nancy Miller, Beth Brooks, Shasi Wilson)
 - Jim Burns and Mark Fisette met with Lakewood attorney to get clarification on the CC&Rs. Our current document does not permit fines.
 - Committee working on a draft for the Compliance and Enforcement policy.
 - The committee wants to send out a survey to the homeowners to gather community input.
 - O Suggestion: **create signs** to post in the neighborhood with a QR code that takes the community member directly to the survey online.
 - CC&Rs do permit penalties to be assigned to infractions on the "common area" in Lakewood.

V. Manager's Report (Carol Wolf, read into the minutes by Michelle)

- Ordered Towing sign at front and No Soliciting sign.
- Asked Noah to bend back the metal plate where someone bent it so it would NOT lock on the tennis courts.
- Spoke with Kiera McDaniel about dam repairs. Carol followed up again with her on Monday 10/28 at 12 pm and Tuesday 10/29 at 4 pm, October 31 at noon. November 3rd at 9:30 am.
- Booked clubhouse for Zerorez cleaning on December 13th from 8:30-10:30.
- Carol spoke to Vincent DeBrock with Heritage Tree. He said the tree in question is NOT top heavy. There are a few larger dead limbs that can be removed but no other trimming should be considered. This is a tree located at Wallace and Wallace Cove that was marked to trim. He will send over a bid. The work will be done around Thanksgiving.
